HISTORY OF CONSUMER CONFIDENCE REPORT (CCR)

- DEVELOPED AS A PART OF THE USEPA SAFE DRINKING WATER ACT OF 1996
- FINAL RULE ON SEPTEMBER 18, 1998
- ONLY AFFECTS CWS AND NOT NTNC
- FIRST CCR DEADLINE TO ISSUE WAS OCTOBER 19, 1999 (USING 1998 DATA)
- SECOND AND ALL SUBSEQUENT REPORTS DUE NO LATER THAN JULY 1 EACH YEAR

HISTORY OF CCR

- FIRST YEAR ALL CCRS HAD TO BE DIRECT-MAILED OR HAND-DELIVERED
- SUBSEQUENT YEARS OFFERED THE FOLLOWING OPTIONS:
 - -DIRECT MAIL OR HAND DELIVERY (REQUIRED IF MCL VIOLATION EXISTED)
 -PUBLICATION OF REPORT IN PAPERS, NEWSLETTERS, ETC.
 -ONLY FOR CWS <u>UNDER</u> 10,000 POPULATION

METHOD OF DELIVERY CWS SERVING <u>UNDER</u> 500

- SYSTEMS MUST HAVE <u>NO</u> MCL VIOLATIONS OR MONITORING VIOLATIONS
- POST NOTICE OF AVAILABILITY OF REPORT
- HANGING CCR IS NOT A SUBSTITUTE FOR POSTING NOTICE OF AVAILABILITY
- LET CUSTOMERS KNOW IN NOTICE WHAT CCR IS AND HOW TO GET A COPY OF THE REPORT

METHOD OF DELIVERY FOR CWS SERVING <u>OVER</u> 500

- SYSTEMS MUST HAVE <u>NO</u> MCL VIOLATIONS OR MONITORING VIOLATIONS
- DIRECT-MAIL TO ALL WATER CUSTOMERS, OR
- HAND-DELIVERY TO ALL WATER CUSTOMERS, OR
- PLACED IN PUBLICATION(S) SERVING THE SERVICE AREA OF CWS, OR
- ELECTRONIC DELIVERY OF REPORT, AND
- GOOD FAITH EFFORTS

FIFTEEN YEARS LATER

• COMMENT I HEARD USEPA OFFICIAL MAKE AT A MEETING SEVEN YEARS AGO:

"THE CCR IS THE BEST THING THAT EVER CAME OUT OF WASHINGTON, D.C."

FIFTEEN YEARS LATER

- UPSIDE:
- HAS PROVIDED CUSTOMERS OF CWS INFORMATION ABOUT THE QUALITY OF THEIR DRINKING WATER
- PROVIDES DATA ON THE DOZENS OF CONTAMINENTS THAT ARE ANALYZED
- PROVIDES TRANSPARENCY

FIFTEEN YEARS LATER

- DOWNSIDE:
- MILLIONS OF TREES KILLED TO MAKE THE PAPER FOR THE REPORTS
- THE SINKING FEELING THAT DARN FEW PEOPLE ACTUALLY LOOK AT THEIR REPORT
- MAY BE BORNE OUT BY # OF QUESTIONS WE RECEIVE
- HOWEVER, CCRs ARE VERY BIG READING IN PRISONS

OPTION AVAILABLE IF A LIST OF REQUIRMENTS ARE MET BY CWS.

- -PRINTING COSTS OF PAPER CCR -POSTAGE COSTS (DIRECT-MAIL) -PUBLISHING COSTS (PAPERS, FLIERS)
- FIRST AFFECTED CCR'S ISSUED IN 2013
 PROVIDES COST SAVINGS THAT INCLUDE:
- OPTION PASSED BY CONGRESS IN JAN, 2013

ELECTRONIC DELIVERY OF CCR MAIN (PRIMARY) DELIVERY METHOD

ELECTRONIC DELIVERY OF CCR MAIN (PRIMARY) DELIVERY METHOD

- CWS SERVES ANY POPULATION
- WEBSITE USED FOR e-CCR MUST TAKE CUSTOMERS <u>DIRECTLY</u> TO THE CCR WITH NO FURTHER NAVIGATION NEEDED
- WEBSITE ADDRESS MUST BE UNDER 40 CHARACTERS
- WEBSITE CCR CONTENT MUST BE EXACTLY THE SAME CONTENT (WORD FOR WORD) AS HARD COPIES MAILED, POSTED, OR PRINTED IN PUBLICATIONS

ELECTRONIC DELIVERY OF CCR MAIN (PRIMARY) DELIVERY METHOD

- WEBSITE CCR MUST BE SAME (WORD FOR WORD) AS THE FINAL COPY SENT TO IEPA
- CCR IN PDF OR HTML FORMAT
- THE e-CCR MUST REMAIN ON THE WEBSITE FOR AT LEAST THREE MONTHS
- LENGTH e-CCR IS ON WEBSITE CAN EXCEED THREE MONTHS
- ORIGINAL CONTENT AND FORMAT CAN NOT CHANGE DURING PERIOD

ELECTRONIC DELIVERY OF CCR MAIN (PRIMARY) DELIVERY METHOD

- e-CCR MUST CONTAIN ALL REQUIRED LANGUAGE, DATA, DEFINITIONS, AND VIOLATIONS, PER THE REGULATION
- PHONE # AND CONTACT PERSON MUST BE LISTED SO CUSTOMERS MAY CALL WITH QUESTIONS OR COMMENTS
- NOTIFICATION OF THE e-CCR WEBSITE ON:
- BILLINGS (STICKERS), SEPARATE POSTCARD, ¼ NEWSLETTER, ETC.

NOTICE FOR E-PAY OR AUTO-PAY CUSTOMERS

- AN EMAIL WITH <u>"IMPORTANT</u> <u>INFORMATION ABOUT YOUR</u> <u>DRINKING WATER QUALITY</u>" IN THE SUBJECT LINE MUST BE SENT TO E-PAY OR AUTO-PAY CUSTOMERS
- BODY OF THE EMAIL WILL INCLUDE THE WEBSITE ADDRESS
- BODY OF EMAIL MUST ALSO INCLUDE LANGUAGE INCLUDED IN THE NEXT SLIDE

E-PAY OR AUTO-PAY NOTICE OF AVAILABILITY

- IMPORTANT:
- A HARD-COPY OF THE CCR MUST BE MAILED DIRECTLY TO ANY EMAIL ADDRESS THAT COMES BACK AS "UNDELIVERABLE"
- KEEP A RECORD OF THIS INFORMATION FOR SUBMISSION TO THE AGENCY, IF REQUESTED DURING SANITARY SURVEY

TIER 3 PUBLIC NOTICES IN e -CCR

- THE e-CCR MAY ALSO BE USED FOR THE DISTRIBUTION OF TIER 3 PUBLIC NOTICES IF:
- THE CORRECT LANGUAGE IS USED
- THE PUBLIC NOTICE CERTIFICATION FORM AND A HARD-COPY OF THE PUBLIC NOTICE IS COMPLETED AND MAILED WITH CCR PACKET TO IEPA

TIER 3 PUBLIC NOTICES IN e-CCR

• KEEP IN MIND THAT SOME PUBLIC NOTICES/CERT. FORM MUST ALSO BE SENT TO THE ILL. DEPT. OF PUBLIC HEALTH, SUCH A P.N. FOR FLUORIDE EXCEEDANCE OF SECONDARY

**FLUORIDE EXCEEDANCE OF 2.0 MG/L BUT UNDER 4.00 MG/L REQUIRES A P.N. AND P.N. CERTIFICATION FORM BE SENT TO <u>BOTH</u> IEPA CAS AND THE IDPH

WHAT IF REQUEST IS MADE FOR HARD COPY OF CCR?

- IF THERE IS A REQUEST FOR A HARD-COPY OF THE CCR:
- THE CWS MUST NOW DO A DIRECT-MAIL OR HAND-DELIVERY TO FULFILL THAT REQUEST
- WE CAN NO LONGER TELL THE REQUESTER TO COME TO US FOR THE REPORT
- CANNOT CHARGE FOR COPY OF REPORT OR RELATED COSTS
- CCR IS NOT A FOIA-ABLE DOCUMENT

GOOD FAITH EFFORTS (SECONDARY)

- ALSO MAKE A GOOD FAITH EFFORT FOR AVAILABLITY TO THE PUBLIC:
- POST IN SCHOOLS, PUBLIC LIBRARIES, MUNICIPAL HALLS, OTHER PUBLIC BUILDINGS
- PROVIDE EXTRA COPIES TO OWNERS OF HOUSING
- FACEBOOK & TWITTER CAN ONLY BE USED AS GOOD FAITH EFFORTS

FINAL COPY SENT TO IEPA VIA MAIL

- PACKET MUST INCLUDE:
- COMPLETED AND SIGNED CCR CERT. FORM
- HARD COPY OF CCR, AS ON WEBSITE
- HARD COPY OF BILL INSERT OR BILL W/NOTIFICATION OF e-CCR & WEBSITE
- HARD COPY OF EMAIL NOTIFICATION TO E-PAY OR AUTO-PAY CUSTOMERS W/SUBJECT LINE, WEBSITE ADDRESS, AND LINK

FINAL COPY SENT TO IEPA VIA MAIL

- PACKET CONTENTS (CONTINUED)
- EMAIL NOTIFICATION OF CCR
 STATEMENT THAT HARD COPIES WERE
 SENT TO THESE ADDRESSES
 W/NOTIFICATION THAT REPORT WAS
 MAILED
- ANY GOOD FAITH (SECONDARY) EFFORTS

IMPORTANT INFORMATION ABOUT CCR CERTIFICATION FORM

- <u>E-CCR CERTIFICATION FORM DIFFERS</u> <u>FROM STANDARD FORM</u>
- CONTACT CCR COORDINATOR OF YOUR SYSTEM'S PLANS TO USE e-CCR AND THE NEED FOR THIS FORM BEFORE PROCEEDING
- FORM WILL BE FORWARDED TO YOU
