Illinois Rural Water Association was the recipient of several awards during the National Rural Water Association's Tribute to Excellence ceremonies held October 7 in conjunction with the H2O-XPO in Louisville, Kentucky. On hand to accept these awards were the IRWA staff and several members of the IRWA Board of Directors.

IRWA was the recipient of two merit awards for their efforts in public relations and member services. Most people associate public relations with advertising but here at IRWA we believe it goes much beyond that and is tied closely to member services. Public relations among the members of the rural water family are actually the practice of unified communication(s) between an association, its members and the general public. IRWA works hard at communicating with their members and others and is honored that this hard work was recognized.

I would like to thank you for the assistance of the IRWA in finding a water leak on a cast iron main that would not surface. We were losing approximately 20,000 gallons of water per day. On Monday, October 12th, Mr. Chuck Woodworth, Circuit Rider #3 came here and located where your equipment showed the leak to be. We were able to dig at this spot and repair the leak. Chuck helped us to pinpoint leaks on a couple of water service lines also. I appreciate the help on keeping our unaccounted for water loss down and the cost savings on chemicals and electricity, etc. Again, on behalf of our city's water department and community, I thank you.
